

Definitions: Regular Contractual Status--in good standing Provider is fully compliant with the terms and conditions of the SR provider Contract. High-Risk/ Conditional status: Provider has not fully completed with sanction criteria including DCF H&S Standards. Status indicates that provider is at risk for contract termination and must meet conditions set by the ELCFH Board as stipulated. SANCTIONS: Probation is an escalated Corrective Action Plan with additional requirements. Suspension is like the probation sanction plus the provider is not allowed to enroll additional SR funded children.
